Call for Entries

Eligibility:

- Open to Residents of Central Ohio. This is a juried art show Showcasing the fur, feathered, hoofed and fin.
- **You may enter up to three pieces of your original artwork created within the last 3 years. Please do not enter artwork that was exhibited at The Arts Castle in the past 3 years.**
- 2D Categories: Painting, Drawing, Photography, Computer Art, Mixed Media.
- 3D Categories: Ceramics, Sculpture, Jewelry, Fiber, Metal/Wood/Glass/Stone.

Awards will be given to the top three placings in both categories as well as the BEST OF SHOW.

Sale of Art Works:

The Arts Castle will collect payments from clients for art work sold during the exhibit. The Arts Castle will retain 40% of the price of the work and will remit the remainder to the artist 10-14 business days following the close of the exhibit.

Insurance: The Arts Castle will carry "property of others" insurance on items received through the day of pick-up on January 10, 2027. However, The Arts Castle is not liable for loss or damage of exhibit items and/or owner property. Any loss, damage or theft not covered by insurance will be completely borne by the owner/artist.
